## BREEDING CONTRACT

This contract, for the year **2009** breeding season, from February 1<sup>st</sup> through September 30<sup>th</sup>, is made and entered into by and between **Shelbourne Farm LLC**, herein designated *stallion representative*, and \_\_\_\_\_ mare owner/representative, lessee, or authorized agent herein designated *mare owner/representative*.

Mare owner agrees to pay for all costs associated with semen shipment to and from Shelbourne Farm LLC, including but not limited to, insurance, "over due" charges and container damage. These expenses are due prior to all shipments in the form of a credit card. (FedEx Account numbers can be given for shipping purposes, see page 5)

A Deposit in the form of a separate Check made payable to Shelbourne Farm LLC, Stallion Agency, for the amount of **\$1000.00** or a Credit Card Number is Due upon signing this contract. The Credit Card shall be put on file and charged as needed for Stallion collections, Semen Shipments and Over due return of container charges. All unused funds from deposit checks shall be refunded after October 31<sup>st</sup> upon the return of final pregnancy report (Page 7) and mare breeding passport (Page 6) and providing all equipment used or borrowed has been returned in good condition. ***Please note: All containers must be returned to Shelbourne Farm LLC, within 3 days of arrival at given shipment location or a \$30.00 per day late fee will be charged. It is the responsibility of the mare owner to make their breeding facility aware of this charge.***

**The Mare Owner/Representative agrees:**

1. To pay Shelbourne farm LLC, the breeding, handling and shipping fees in full, prior to shipment of semen.
2. That the mare owner/representative is entitled to up to **two (2)** insemination doses for the payment of breeding fee. If a third and /or fourth insemination dose is needed (there is a limit of four (4) frozen breeding doses per mare in any one breeding season) the owner/representative shall pay the sum of \$\_\_\_\_\_ for each insemination dose. **(Applies to frozen semen only)**
3. That each and every Stallion collection shall be paid for prior to the collection of the above referenced Stallion in the sum of **\$250.00** made payable to **B.W. Furlong & Associates**. (Credit card payment accepted). Certain Stallions have a limited amount of collections that are performed each year, which in turn means a limited amount of bookings will be taken each year. In these certain cases the mare owner will be limited to 4 collections per mare per year and no more that 2 collections within the same month. **(Applies to fresh cooled semen only)**
4. To make own arrangements for storing frozen semen.
5. To return all unused straws, once the mare has been confirmed in foal.
6. To provide registration numbers (if applicable) and I.D. papers (i.e. copy of coggins or passport etc)
7. To have mare in sound breeding condition.
8. To complete and return all appropriate paper work. All breeding passports and final pregnancy reports must be returned by October 1<sup>st</sup> of the year bred for our records.
9. To inform stallion representative as soon as possible in advance of needing semen. Preferably, 48 hours notice is needed for frozen semen, but every effort will be made when short notice is given, to insure that semen arrives when needed. For fresh cooled semen, notice must be given by 10 am the morning prior to the day of the intended insemination. (There are no collections on Saturdays or Sundays).
10. To have mare inseminated with frozen semen by a licensed Veterinarian.
11. That stallion representative will not be held responsible for accident, illness, disease or death of mare or foal under any circumstances.
12. To pay all expenses for fresh cooled or frozen semen, including handling and transport, shipping and courier fees that may have accrued due to special requests etc., and agrees to reimburse the stallion representative any fees within ten (10) days of being informed of the charges by the stallion representative
13. To assume responsibility for semen container. If container is lost or damaged while in transit either to or from the mare owner/representative facility, mare owner/rep. shall pay to stallion rep. The sum of **\$800.00** per container. (We insure all shipments for the cost of the container plus its contents; we ask that you use the pre-addressed **FedEx** forms for return shipment to insure appropriate insurance).
14. That container must be returned to stallion representative by **FedEx** within 3 days of receipt at the mare owner/rep/ facility. **A \$30.00 per day late fee will be charged to mare owner/rep.**
15. To assume responsibility for determining eligibility of mare for inclusion in any registry.
16. That a licensed veterinarian indicating the number of straws shall sign the mare-breeding passport used and returned to the stallion rep. Even if mare has failed to become pregnant.

**The Stallion Representative Agrees;**

1. The stallion rep. will provide viable fresh or frozen semen.
2. That mare owner may purchase extra insemination doses at **\$300.00** per dose for up to two (2) extra insemination doses after the initial two doses. Stallion rep. Retains the right to limit number of doses sold
3. Stallion Rep. retains the right to refuse to breed the mare owner/rep. Mare at any time. Stallion rep. will first deduct any costs incurred by the mare owner/rep., and then refund any unused portion. **Booking fees are non-refundable.**

**The Stallion and Mare Representatives Mutually Agree;**

1. This contract is not valid unless completed and signed in full by both parties.
2. Stallion Rep. And Mare Rep. Assume all risks of loss or damage to their own horse (and foal)
3. This agreement is not transferable by Mare rep. To any other party unless written permission has been given by the stallion Rep. And /or the stallion Owner
4. This agreement is binding upon parties, their heirs and assigns *and may be amended only in writing by the parties, and is governed by the laws of the state of New Jersey.*
